### **Basic Professional Services of Funeral Director and Staff \$895**

This is the basic charge we charge to each family we serve for our professional expertise in assisting them. It includes, but is not limited to, a proportionate share of the taxes, licenses, utilities and business expenses necessary to serve the public in a professional manner. Also included in this fee is the consultation with the family, clerical, and administrative services, preparation and filing of necessary permits and other documents, consultation with the clergy, cemetery, crematory, other funeral directors, airlines, assistance with insurance papers, arranging the funeral or memorial service as selected, and placing newspaper notices. There will be an additional fee for the direction and supervision of the service selected. The fee for our basic services and overhead will be added to the total cost of the funeral or memorial service you select. This fee is already included in our package price for a direct cremation, immediate disposition, and forwarding or receiving remains from another funeral home.
